Replace the tolerance for dimension " $\geq 10,8$ " with " $\leq 10,8$ ".

Replace the tolerance for dimension " $\geq 7,8$ " with " $\leq 7,8$ ".

Replace the tolerance for dimension " $\leq 6,1$ " with " $\geq 6,1$ ".

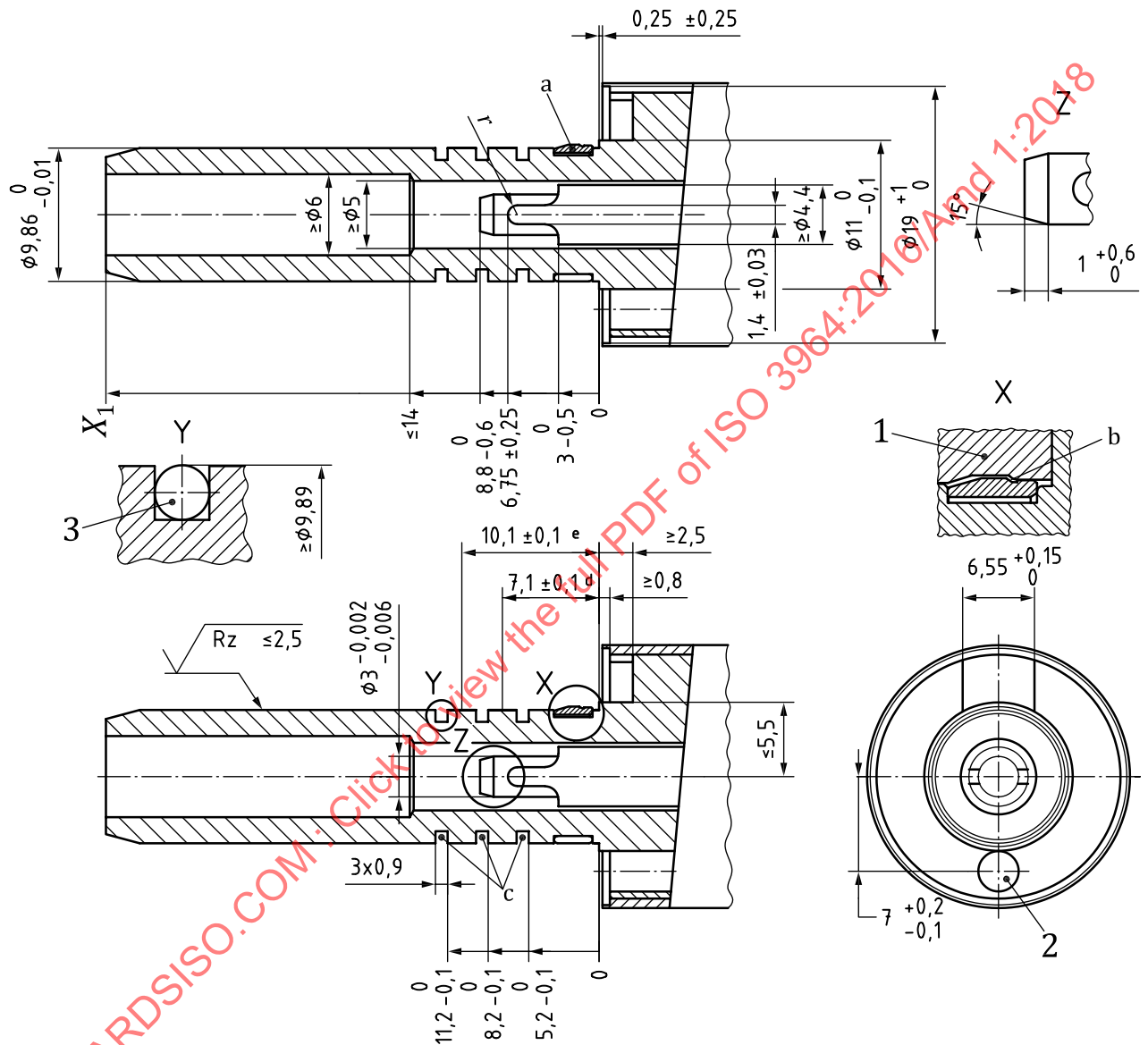
