STEEL BARS AND FORGINGS 0.25Mo (0.35 - 0.40C) (SAE 4037)

1. SCOPE:

- 1.1 Form: This specification covers an aircraft-quality, low-alloy steel in the form of bars, forgings, and forging stock.
- 1.2 Application: Primarily for parts with sections 0.375 in. (9.525 mm) or less in thickness at the time of heat treatment which require a through hardening steel capable of developing hardness of approximately 40 HRC when properly hardened and tempered and also parts with thinner sections which require proportionately higher hardness.

2. APPLICABLE DOCUMENTS: The following publications form a part of this specification to the extent specified herein. The latest issue of Aerospace Material Specification (AMS) and Aerospace Standards (AS) shall apply. The applicable issue of other documents shall be as specified in AMS 2350.

3. TECHNICAL REQUIREMENTS:

- 3.1 Composition: Shall conform to the following percentages by weight, determined by wet chemical methods in accordance with ASTM E350, by spectrographic methods in accordance with Federal Test Method Standard No. 151, Method 112, or by other approved analytical methods.

- 3.1.1 Check Analysis: Composition variations shall meet the requirements of AMS 2259, paragraph titled "Low Alloy Steels".

- 3.2 Condition: The product shall be supplied in the following condition; hardness and tensile strength, as applicable, shall be determined in accordance with ASTM A370:

3.2.1 Bars:

- 3.2.1.1 Bars 0.500 In. (12.700 mm) and Under in Diameter or Distance Between Parallel Sides: Cold finished having tensile strength not higher than 130,000 psi (896 MN/m²) or equivalent hardness.

- 3.2.1.2 Bars Over 0.500 In. (12.700 mm) in Diameter or Distance Between Parallel Sides: Hot finished having hardness not higher than 229 HB or equivalent except that bars ordered cold finished may have hardness as high as 241 HB or equivalent.

- 3.2.2 Forgings: As ordered.

- 3.2.3 Forging Stock: As ordered by the forging manufacturer.

- 3.3 Properties: The product shall conform to the following requirement; hardness testing shall be performed in accordance with ASTM A370:

- 3.3.1 Hardenability: Shall be J52=1 min and J30=5 min, determined on the standard end-quench test specimen in accordance with ASTM A255 except that the steel shall be normalized at 1700 F $\pm$ 10 (926.7 C $\pm$ 5.6) and the test specimen austenitized at 1550 F $\pm$ 10 (843.3 C $\pm$ 5.6). The hardenability test is not required on a product which will not yield a suitable specimen but the steel from which the product is made shall conform to the hardenability specified.

- 3.3.2 Grain Size: Predominantly 5 or finer with occasional grains as large as 3 permissible, ASTM E112, McQuaid-Ehn test.

- 3.3.3 Macrostructure: Visual examination of transverse sections of bars and forging stock, etched in accordance with ASTM E381 in hot hydrochloric acid (1:1) at 160 - 180 F (71.1 - 82.2 C) for sufficient time to develop a well-defined macrostructure, shall show no injurious imperfections such as pipe, internal cracks, porosity, segregation, and inclusions detrimental to fabrication or to performance of parts. Macrostructure shall be equal to or better than the following macrographs of ASTM E381.

3.3.4 Decarburization:

- 3.3.4.1 Bars ordered ground, turned, or polished shall be free from decarburization on the ground, turned, or polished surfaces.
- 3.3.4.2 Allowable decarburization of bars and billets ordered for redrawing or forging or to specified microstructural requirements shall be as agreed upon by purchaser and vendor.
- 3.3.4.3 Decarburization of bars to which 3.3.4.1 or 3.3.4.2 is not applicable shall be not greater than shown in Table I.

- 3.3.4.4 Limits for depth of decarburization of bars over 4.000 in. (101.600 mm) in nominal diameter or distance between parallel sides shall be as agreed upon by purchaser and vendor.

3.3.4.5 Decarburization shall be measured by the microscopic method or by Rockwell Superficial 30-N scale or equivalent hardness testing method on hardened but untempered specimens protected during heat treatment to prevent changes in surface carbon content. Depth of decarburization, when measured by a hardness method, is defined as the perpendicular distance from the surface to the depth under that surface below which there is no further increase in hardness. Such measurements shall be far enough away from any adjacent surface to be uninfluenced by any decarburization or lack of decarburization thereon.

3.3.4.5.1 When determining the depth of decarburization, it is permissible to disregard local areas provided the decarburization of such areas does not exceed the limits above by more than 0.005 in. (0.127 mm) and the width is 0.065 in. (1.651 mm) or less.

3.4 Quality: Steel shall be aircraft quality conforming to AMS 2301. The product shall be uniform in quality and condition, clean, sound, and free from foreign materials and from internal and external imperfections detrimental to fabrication or to performance of parts.

3.4.1 Bars ordered ground, turned, or polished shall be free from seams, laps, tears, and cracks open to the ground, turned, or polished surfaces.

3.4.2 Product ordered to surface conditions other than ground, turned, or polished shall, after removal of the standard machining allowance, be free from seams, laps, tears, cracks, and other defects exposed to the machined surfaces. Standard machining allowance shall be in accordance with values shown in AS 1182.

3.5 Sizes: Except when exact lengths or multiples of exact lengths are ordered, bars will be acceptable in mill lengths of 6 - 20 ft (1.8 - 6.1 mm) but not more than 10% of any shipment shall be supplied in lengths shorter than 10 ft (3 m).

3.6 Tolerances: Unless otherwise specified, tolerances for bars shall conform to all applicable requirements of AMS 2251; for all hexagons, tolerances for cold finished shall apply.

4. QUALITY ASSURANCE PROVISIONS:

4.1 Responsibility for Inspection: The vendor shall supply all samples and shall be responsible for performing all required tests. Results of such tests shall be reported to the purchaser as required by 4.5. Purchaser reserves the right to perform such confirmatory testing as he deems necessary to assure that the product conforms to the requirements of this specification.

4.2 Classification of Tests: Tests to determine conformance to all technical requirements of this specification are classified as routine control tests.

4.3 Sampling: Shall be in accordance with the following:

4.3.1 Bars: AMS 2370.

4.3.2 Forgings and Forging Stock: AMS 2372.

4.4 Approval: When specified, approval and control of critical forgings shall be in accordance with AMS 2375.

4.5 Reports:

4.5.1 The vendor of the product shall furnish with each shipment three copies of a report of the results of tests for chemical composition, hardenability, grain size, macrostructure, and AMS 2301 frequency-severity rating of each heat in the shipment. This report shall include the purchase order number, heat number, material specification number and its revision letter, size, and quantity from each heat. If forgings are supplied, the part number and the size and source of stock used to make the forgings shall also be included.
