STEEL BARS AND FORGINGS 1.8Ni - 0.25Mo (0.38 - 0.43C) (4640) Heat Treated, 125,000 psi (860 MPa) Tensile Strength

1. SCOPE:

1.1 Form: This specification covers an aircraft-quality, low-alloy steel in the form of heat treated bars and forgings.

1.2 Application: Primarily for parts with sections 1.0 in. (25 mm) and under in nominal thickness requiring a minimum tensile strength of 125,000 psi (860 MPa).

2. APPLICABLE DOCUMENTS: The following publications form a part of this specification to the extent specified herein. The latest issue of Aerospace Material Specifications and Aerospace Standards shall apply. The applicable issue of other documents shall be as specified in AMS 2350.

3. TECHNICAL REQUIREMENTS:

3.1 Composition: Shall conform to the following percentages by weight, Ø determined by wet chemical methods in accordance with ASTM E350 or by spectrographic or other analytical methods approved by purchaser:

3.1.1 Check Analysis: Composition variations shall meet the applicable requirements of AMS 2259.

3.2 Condition: The product shall be supplied in the following condition:

3.2.1 Bars:

3.2.1.1 Bars 0.500 In. (12.50 mm) and Under in Nominal Diameter or Distance Between Parallel Sides: Cold finished, hardened, and tempered.

3.2.1.2 Bars Over 0.500 In. (12.50 mm) in Nominal Diameter or Distance Between Parallel Sides: Hot finished, or cold finished when so ordered, hardened, and tempered.

3.2.2 Forgings: Hardened and tempered.

3.3 Properties: The product shall conform to the following requirements; hardness and tensile testing shall be performed in accordance with ASTM A370:

3.3.1 Macrostructure: Visual examination of transverse sections as in 4.3.3 from bars, billets, and forging stock, etched in accordance with ASTM E381 in hot hydrochloric acid (1:1) at 160° - 180°F (70° - 80°C) for sufficient time to develop a well-defined macrostructure, shall show no pipe or cracks. Porosity, segregation, inclusions, and other imperfections shall be no worse than the following macrographs of ASTM E381:

3.3.2 Grain Size: Predominantly 5 or finer with occasional grains as large as 3 permissible, determined in accordance with ASTM E112.

3.3.3 Decarburization:

3.3.3.1 Bars ordered ground, turned, or polished shall be free from decarburization on the ground, turned, or polished surfaces.

3.3.3.2 Decarburization of bars to which 3.3.3.1 is not applicable shall be not greater than shown in Table I.

3.3.3.2.1 Limits for depth of decarburization of bars over 3.000 in. (75.00 mm) in nominal diameter or distance between parallel sides shall be as agreed upon by purchaser and vendor.

3.3.3.3 Decarburization shall be measured by the microscopic method or by Rockwell Superficial 30-N scale or equivalent hardness testing method on specimens cut from bars. Depth of decarburization, when measured by a hardness method, is defined as the perpendicular distance from the surface to the depth under that surface below which there is no further increase in hardness. Such measurements shall be far enough away from any adjacent surface to be uninfluenced by any decarburization or lack of decarburization thereon.

3.3.3.3.1 When determining the depth of decarburization, it is permissible to disregard local areas provided the decarburization of such areas does not exceed the above limits by more than 0.005 in. (0.12 mm) and the width is 0.065 in. (1.65 mm) or less.

3.3.4 Tensile Properties: Specimens cut longitudinally from bars 1.00 in. (25 mm) and under in nominal diameter or distance between parallel sides and from forgings 1.00 in. (25 mm) and under in nominal cross-section with axis of specimen in the area of gage length within 15 deg of parallel to the forging flow lines shall have the following properties:

Tensile Strength, min	125,000 psi (860 MPa)
Yield Strength at 0.2% Offset, min	100,000 psi (690 MPa)
Elongation in 4D, min	16%
Reduction of Area, min	50%

3.3.4.1 Transverse tensile properties and longitudinal tensile properties of bars over 1.00 in. (25.0 mm) in nominal diameter or distance between parallel sides and of forgings over 1.00 in. (25.0 mm) in nominal cross-section shall be as agreed upon by purchaser and vendor.

3.3.5 Hardness: Should be 262 - 311 HB or equivalent but the product shall not be rejected on the basis of hardness if the tensile property requirements of 3.3.4 are met.

3.4 Quality:

3.4.1 Steel shall be aircraft quality conforming to AMS 2301.

3.4.2 The product, as received by purchaser, shall be uniform in quality and condition, sound, and free from foreign materials and from imperfections detrimental to usage of the product.

3.4.2.1 Bars ordered ground, turned, or polished shall be free from seams, laps, tears, and cracks open to the ground, turned, or polished surfaces.

3.4.2.2 Product ordered to surface conditions other than ground, turned, or polished shall, after removal of the standard machining allowance, be free from seams, laps, tears, cracks, and other defects exposed to the machined surfaces. Standard machining allowance shall be in accordance with AS 1182.

3.4.3 Grain flow of die forgings, except in areas having end grain, shall follow the general contour of the forgings, showing no evidence of re-entrant flow.

3.5 Sizes: Except when exact lengths or multiples of exact lengths are ordered, $\emptyset$ straight bars will be acceptable in mill lengths of 6 - 20 ft (2 - 6 m) but not more than 10% of any shipment shall be supplied in lengths shorter than 10 ft (3 m).

3.6 Tolerances: Bars shall conform to all applicable requirements of AMS 2251 or MAM 2251.

4. QUALITY ASSURANCE PROVISIONS:

4.1 Responsibility for Inspection: The vendor of the product shall supply all samples for vendor's tests and shall be responsible for performing all required tests. Results of such tests shall be reported to the purchaser as required by 4.5. Purchaser reserves the right to sample and to perform any confirmatory testing deemed necessary to ensure that the product conforms to the requirements of this specification.

4.2 Classification of Tests:

4.2.1 Acceptance Tests: Tests to determine conformance to all technical $\emptyset$ requirements of this specification are classified as acceptance tests and shall be performed on each heat or lot as applicable.

4.2.2 Preproduction Tests: Tests of forgings to determine conformance to all applicable technical requirements of this specification when AMS 2375 is specified are classified as preproduction tests and shall be performed prior to or on the first-article shipment of a forging to a purchaser, when a change in material, processing, or both requires reapproval as in 4.4, and when purchaser deems confirmatory testing to be required.

4.2.2.1 For direct U.S. Military procurement of forgings, substantiating test data and, when requested, preproduction forgings shall be submitted to the cognizant agency as directed by the procuring activity, the contracting officer, or the request for procurement.

4.3 Sampling: Shall be in accordance with the following:

4.3.1 Bars: AMS 2370.

4.3.2 Forgings: AMS 2372.

4.3.3 Samples for macrostructure (3.3.1) testing shall be full cross-sectional specimens obtained from the finished billet or suitable rerolled product representing the top and bottom of at least the first, middle, and last usable ingots of each heat.

4.4 Approval: When specified, approval and control of forgings shall be in accordance with AMS 2375.

4.5 Reports:

4.5.1 The vendor of the product shall furnish with each shipment a report showing the results of tests for chemical composition, macrostructure, grain size, and AMS 2301 frequency-severity rating of each heat and for tensile properties and hardness of each lot. This report shall include the purchase order number, heat number, AMS 6317E, size and quantity from each heat. If forgings are supplied, the part number and the size and melt source of stock used to make the forgings shall also be included.

4.5.2 The vendor of finished or semi-finished parts shall furnish with each shipment a report showing the purchase order number, AMS 6317E, contractor or other direct supplier of material, part number, and quantity. When material for making parts is produced or purchased by the parts vendor, that vendor shall inspect each lot of material to determine conformance to the requirements of this specification and shall include in the report either a statement that the material conforms or copies of laboratory reports showing the results of tests to determine conformance.
